1. The breeding must be paid as follows:

The payment must be complete before the first shipping.
2. The shipping costs it must to be pay by the mare's owner. The request sent by courier must be submitted no later than 72 hours before delivery.
3. This contract is subject entirely to the law and the Italian jurisdiction.
4. By signing this contract the ownership of the dam is fully and expressly declares that the property aware of the stallion and his successors (if any borrower, veterinarians, employees and / or employees) will be kept totally free from any claim from ownership of the dam itself or its related third parties in respect of any damage caused by your decision to use artificial insemination to breed the mare.
5. With this contract you receive 2 doses of frozen semen. For every additional dose needed there will be a charge of 250€/dose. Max 2 doses per shipment.
6. The Stallion Manager is not responsible for the untimely arrival or condition of the frozen transported semen as we have no control over the shipment after it leaves our custody.
7. Due to the high demand for shipped semen, it is imperative that the container be returned to the Stallion Manager within 72 hours, pay a fine of € 150 for the cost of the container. Return shipping costs incurred are the responsibility of the mare owner.
8. 23 Quarter Horses, owner of the stallion Ricochet Rooster, will rebreed the mare only for the following year under these condition:
 - a. The mare reabsorbs the embryo.
 - b. The mare aborts (medical certificate required and only up 5 days after abort).
 - c. The mare foals and the foal death no more than the 7th day foaling (medical certificate required).After the 7th day after foaling the owner of the stallion is free of any responsibility. That commitment will not have value in the event that the mare was not vaccinated against Rinopolmonite during the 5 th, 7 th and 9 th month of gestation. These requirements will be provided on request medical certification.
A rebreed fee of 250,00 euro will be charged. If the mare does not return for a rebreeding the following year, and other arrangements have not been made, any and all fees paid shall be forfeited. The right to a rebreed is cancelled and the Stallion Owner and the Breeder are released from all further obligations to this contract.
